#### FISCAL IMPACT:

**Item History:** The town has a pressure washer that is used to clean town equipment. For the past several years we have been having issues with the burner on the existing unit. It has been repaired several times but continues to fail.

We would like to replace the unit with a electric direct drive hot water pressure washer from Green Bay Pressure Systems. The unit we would like to purchase is an M-T-M Hot water/electric/oil fired DH-2003-SE0E2M. It has 2000 psi water pressure along with a 207,200 BTU per hour burner. It cost \$4950.00, which includes a \$500 trade in for our old unit.

This unit will be used for cleaning all town equipment.

**Recommended Action:** I would recommend the purchase of the electric direct drive hot water pressure washer from Green Bay Pressure Systems for \$4950.00.

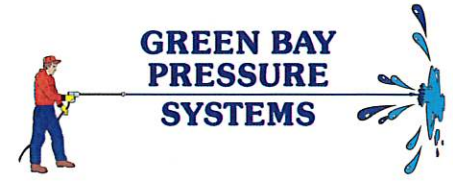

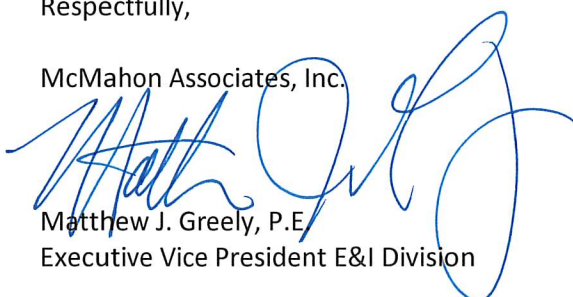

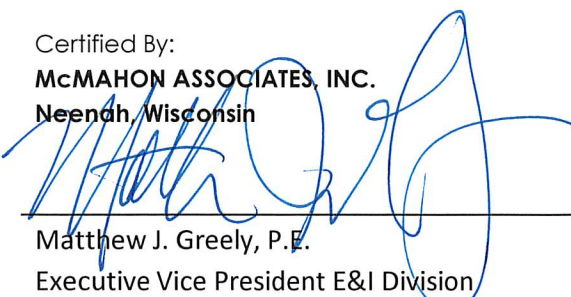
