In anticipation of future water/sewer extensions on the west side of I-41 along Mid Valley Drive, to serve upcoming proposed or existing projects, McMahon has developed cost estimates on their scope of needed work for planning and design services for such utility extensions. Supervisor Brienen made the motion to approve design services to review future water & sewer extension on Mid Valley Drive, by McMahon as presented. Supervisor Farvour seconded the motion. Supervisor Perock recused himself. The motion carried 4-0.
