- 1. Call to Order
  - Call to order by Chair Lanny Tibaldo at 6:02pm
- 2. Roll Call

- 4. Approve Agenda
  - Skip Lee made a motion to approve the agenda, second by Mike VandeHei. Motion carried unanimously.
- 5. Approve Minutes from October 13, 2021 meeting.
  - Kyle Treml made a motion to approve minutes as presented, second by Travis Runke. Motion carried unanimously.
- 6. Public comments upon matters not on the Agenda.
  - Brian Liesch Trouble with lot in town. He owns Lot 18 in Lawrence Parkway Estates. Concerned about his neighbor's house and the grade of the lot. Believes the lot grade has changed the scope of his lot. He needs a flat lot for handicap accessibility. Feels his neighbor's basement is too high and the grade is too steep.
