Administrator Patrick Wetzel discussed each section of the approval criteria in the Planned Development District Ordinance in detail. There was discussion on the comprehensive plan, utilities, construction process, parking area, landscaping, berms, traffic flow, stormwater, job creations, parks and recreation, land uses regarding trails and impact on schools and town resources. Representatives from T.C. Pursuit were in attendance to review the proposed plans and answer questions.
